The Masters will be delivered on-island by University of Portsmouth Faculty with substantial Cayman Islands experience. The teaching is set in the context of the Cayman Islands and recognises the Cayman economic, social and legal dimensions. ### **Master's entry**

This Master's is open to HR professionals and to Senior Managers and the entry requirements are:

1. A Bachelor's degree or equivalent, or
2. A CIPD Certificate in HR Practice (CHRP), or equivalent, or
3. Applicants without a formal qualification but with significant senior management or HR experience will also be considered.

### **Classes on-island**

The Master's is delivered in seven Wednesday to Friday blocks from 8:30am to 4:30pm in each of 2 academic years. Classes will take place at the University College of the Cayman Islands (UCCI) and you will study the following modules:

**Year one:** Leadership and management skills

People resourcing, learning and talent management'

**Year two:** Managing human resources and the employment relationship in context

The HR practitioner and the global perspective

This followed by a Research Project which will be supervised by a personal Dissertations tutor from Portsmouth.
